

Property

Lot 1 comprises two arable field enclosures totalling 22.11 acres with access from the road along the northern boundary.

Lot 2 comprises three arable field enclosures totalling 17.56 acres with access from Splatt Lane along the western boundary.

Lot 3 comprises a single arable field enclosure of 3.39 acres with access from Splatt Lane along the western boundary.

Lot 4 comprises a single enclosure of pastureland totalling 5.01 acres with access from Splatt Lane along the eastern boundary, and from the road along the northern boundary.

Location

The land is located along Splatt Lane, a short distance to the north of the village of Spaxton on the edge of the Quantock Hills and close to the A39.

Tenure

The freehold of the land is offered for sale. Lots 1, 2, and 3 are subject to a Farm Business Tenancy which expires on 31st October 2025. Lot 4 will be sold with vacant possession upon completion of the sale. The land will be sold subject to a covenant to use the land for agricultural, equestrian, horticultural, and/or forestry purposes.



Method of Sale

The land is offered for sale by online auction with a guide prices* as listed below. The property will be sold subject to reserve prices**. The online auctions will conclude on Wednesday 5th February 2025 with Lot 1 concluding at 1pm, Lot 2 concluding at 2pm, Lot 3 concluding at 3pm, and Lot 4 concluding at 4pm.

Lot 1: £230,000 guide price.

Lot 2: £185,000 guide price.

Lot 3: £50,000 guide price.

Lot 4: £70,000 guide price.


